You are responsible for paying all Ambit supply charges for the period that you received Ambit service.   |

| Cancellation of Service:     | You have the right to cancel your service with Ambit Energy at any time, subject to any early termination fee that would apply. To cancel service, you must notify Ambit Energy. Ambit Energy is required to notify Central Maine Power of the cancellation within two (2) business days of your request. Central Maine Power will then process the cancellation for you. Unless you have signed up with another supplier, you will receive standard offer service, which is a supply service available to all electricity customers through a process administered by the PUC.
