- 2. ENTRY. Each participant who registers for Ambition 2021 ("Ambition") between prior to 12 A.M. Central Standard Time (CST) on the morning of June 7, 2021 or following the "alternate entry" procedure in Section 3 below will be entered in a drawing for a chance to win an Ambition Experience according to the rules and procedures set forth below (the "Sweepstakes"). Ambit will randomly select two winning names on June 10, 2021. The drawing will be conducted via Zoom and will be viewable on Facebook. Your name entered during registration is your entry into the Sweepstakes. Please note: There is no purchase necessary to enter. Participation in the drawing is not required, nor is the drawing the main or sole reason why you should participate in Ambition. Among other benefits, Ambition offers its participants educational sessions, informative presentations and networking opportunities.
- **3.
