

Schedule A – Electric Distribution Company Supply Charges

For comparison to your supplier's electric supply service price, the tables below include The Connecticut Light and Power Company d/b/a Eversource Energy ("Eversource") and The United Illuminating Company's ("UI") Standard Service supply rates and Last Resort Service rates (if applicable) that you do not pay by enrolling with your supplier. The tables below include for both Eversource and UI the Standard Service supply rates effective January through June and July through December 2022 and Last Resort Service rates effective April through June and July through September 2022. The tables are provided by the Public Utilities Regulatory Authority in its decision approving these rates.

As a reminder, the supply portion of the bill is not your total bill. In addition to the price for your electric supply service from your supplier, you will continue to pay Eversource or UI, as the case may be, for delivery service and other charges.
