1. <u>Sponsor</u>. The sole sponsor of this Sweepstakes is Ambit Marketing, LLC ("Sponsor").

2. How to Enter. Each participant who registers for Ambition 2021 ("Ambition") and opts in either in person or virtually (as detailed below) will be entered in a random drawing for a chance to win a prize (the "Sweepstakes"). The Sweepstakes starts on August 26, 2021 and ends on August 28, 2021. For attendees attending in-person, if you are eligible and meet the Ambition registration requirements, you will be randomly assigned a number. This number is your entry into the drawing, and you may opt into the Sweepstakes by placing a card with your number in the drawing tumbler during the event as directed by event staff. Ambit will randomly select winning in-person attendee numbers on Thursday, Friday and Saturday, August 26, 27 and 28 of 2021. If your number is selected during a first prize drawing, you will be invited to play a "Plinko-style" inperson game to identify which of the remaining first prizes you will receive. If your number is selected in the grand prize drawing Saturday, August 28. For attendees watching virtually, if you are eligible and meet the Ambition registration requirements, you will have access to an application in which you may opt in if desired to participate in the drawing. Ambit will randomly select a winning virtual attendee on Thursday, Friday and Saturday, August 26, 27 and 28 of 2021. If selected in the random drawing, you will be invited to join via Zoom to play a game to identify which prize you will receive. Please note: There is no purchase necessary to enter. Participation in the drawing is not required, nor is the drawing the main or sole reason why you should participate in Ambition. Among other benefits, Ambition offers its participants educational sessions, informative presentations and networking opportunities. There is a limit of one (1) entry per person during the Sweepstakes Period. All entries become the sole and exclusive property of Sponsor. Entries will not be returned and receipt of entries will not be acknowledged.

3. <u>Eligibility</u>. Eligibility is limited to persons at least twenty-one (21) years of age, who are legal residents of the United States or its territories and possessions, and who are registered to attend Ambition. Each participant who registers for Ambition by the morning of August 28, 2021 will be eligible for the Sweepstakes. Limit of one (1) entry per person. For each giveaway segment, we will draw numbers from a barrel for in-person drawings and draw numbers through an online raffle method for virtual drawings. For the grand prize drawings, we will use the same in-person and virtual methods of drawing numbers. For the grand prize drawings, we will first draw eight (8) numbers of potential grand prize winners (4 in-person and 4 virtual). The 8 will then play a game to win a grand prize. One in-person player will

win a grand prize and one virtual player will win a grand prize. The remaining 6 of the original 8 drawn will receive a prize for playing the game. Only twelve (13) total will win first prizes and only two (2) total will win grand prizes. The odds of winning depend on the number of eligible entries received. Approximately 3,000 participants will be entered into the drawing. Ambit's determination of the winner by the random selection of an entry will be final and binding. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
