## Residential and Small Non Residential Standard Offer Service Consumer Information About Your Electricity Supply

April-2025

Electricity suppliers in Maine must, by Maine law, provide fact sheets, or "uniform disclosure labels" from time to time to educate consumers about their electricity service. Your electricity is *delivered* by Versant Power, but the electricity itself is supplied by Ambit Northeast, LLC.

This fact sheet provides consumer information about the power sources and air emissions of service provided by this electricity supplier.

## **Additional Information and Requirements**

**POWER SOURCES** —Maine law requires retail electricity providers to periodically provide information to their customers on the mix of power sources used by the provider to serve their Maine customers' load.

**EMISSIONS** — <u>Carbon Dioxide (CO2)</u> is released when certain fuels are burned. It is considered a greenhouse gas and a major contributor to global warming. <u>Nitrogen Oxides (NOX)</u> form when certain fuels are burned at high temperatures. They are considered contributors to acid rain and ground-level ozone (or smog). <u>Sulfur Dioxide (SO2)</u> is formed when fuels containing sulfur are burned. Major health effects associated with SO2 include asthma, respiratory illness and aggravation of existing cardiovascular disease. The production of electricity can produce other harmful emissions and have other environmental impacts. Environmental impacts differ among individual power plants.
