

AMBITION 2023 TERMS AND CONDITIONS



I, the individual named in this registration, desire to participate in AMBITION ("Event") provided by Ambit Marketing, LLC, a Texas Limited Liability Company ("Company" or "Ambit") with offices located at 6555 Sierra Drive, Irving, Texas, 75039. As lawful consideration for being permitted by the Company to participate in the Event, I agree to these Terms and Conditions and Release of Liability ("Terms").

Event Registration

All attendees must register and pay a fee to participate in the Event. The registration fees can be found on the Ambit Energy EventCenter website ("EventCenter"). The registration fee includes access to all portions of the Event posted on EventCenter. All attendees will be required to check in to the AMBITION on-site in order to have access to enter the Event.

Order Confirmation

If the purchaser does not receive an email confirmation after submitting payment, or if the purchaser experiences any type of process error or service interruption after submitting payment, it is the responsibility of the purchaser to confirm with Ambit whether or not the online order was received. Ambit Energy will not be responsible for losses (monetary or otherwise) if purchaser fails to confirm finalized registration.

AMBITION "Ticket"

Authority to Register and/or to Act as Agent

I represent and warrant to Ambit that I have full legal authority to complete this Event registration on behalf of registrants and submit to these Terms on their behalf, including full authority to assume and waive liability and to make use of the credit or debit card to which fees will be charged.

Indemnification and Covenant Not to Sue

By accepting, you agree to defend, indemnify, and hold harmless Ambit against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind, including reasonable attorney fees, fees and the costs of enforcing any right to indemnification under this agreement, and the cost of pursuing any insurance providers, incurred by indemnified party in a final judgment, arising out or resulting from any claim of a third party related to the event.

By accepting, you hereby expressly waive and release any and all claims, now known or hereafter known in any jurisdiction throughout the world, against Ambit, and its officers, directors, employees, agents, affiliates, successors, and assigns (collectively, "Releasees") arising out of or attributable to your participation in the event, whether arising out of the negligence of the Company or any Releasees or otherwise. Force Majeure

Severability
