- 1. SPONSOR. The sole sponsor of this Sweepstakes is Ambit Holdings, LLC ("Sponsor").
- 2. HOW TO ENTER. Each participant who registers for AMBITION 2024 ("AMBITION") and attends the event in person will be eligible to be entered in a random drawing for a chance to win a prize in the AMBITION 2024 \$20,000 Challenge. To become eligible for the drawing, consultants must (1) personally sponsor a new consultant or consultants between 12:00:00 a.m. CT, Thursday, August 1, 2024, through 11:59:59 p.m. CT, Thursday, August 29, 2024; and (2) be registered for AMBITION by Friday, August 30, 2024, at 1:00:00 p.m. CT and checked in in-person for AMBITION by Friday, August 30, 2024, at 1:00:00 p.m. CT. Two eligible consultant for each of four (4) prize levels will be drawn randomly during the AMBITION event. Eligible consultants will only be entered in the drawing for the highest prize level for which they qualified. Please note: There is no purchase necessary to enter. Participation in the drawing is not required, nor is the drawing the main or sole reason why you should participate in AMBITION. Among other benefits, AMBITION offers its participants educational sessions, informative presentations, and networking opportunities. All entries become the sole and exclusive property of Sponsor. Entries will not be returned, and receipt of entries will not be acknowledged.
- **3. ATTENDANCE BONUS.** All drawing winners will receive an additional \$250 for every personal Marketing consultant who is present at AMBITION.
- **4. ELIGIBILITY.** Eligibility is limited to persons at least twenty-one (21) years of age, who are legal residents of the United States or its territories and possessions, and who meet the consultant sponsoring requirements above and are registered for AMBITION and check in in-person to the event by the time and day above. **Limit of one (1) entry per person.** The drawing is subject to all applicable federal, state, and local laws and regulations and void where prohibited. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
