

**AMBITION 2026
GIVEAWAY SWEEPSTAKES OFFICIAL RULES**

1. SPONSOR. The sole sponsor of this Sweepstakes is Ambit Marketing, LLC (“Sponsor”).

2. HOW TO ENTER. Each participant who registers for AMBITION 2026 (“AMBITION”) and attends in person will receive a door prize ticket or tickets containing a random number. The Sweepstakes starts on September 3, 2026 and ends on September 5, 2026. You may opt in to the Sweepstakes by placing a card with your number in the drawing tumbler during the event as directed by event staff. Ambit will randomly select winning in-person attendee numbers on Thursday, Friday and Saturday, September 3, 4 and 5 of 2026. If your number is selected during a prize drawing, you may be invited to compete in a game or draw a prize. If your number is selected in the grand prize drawing Saturday, September 5, you will be invited to play for the Grand Prize. There is no purchase necessary to enter. Participation in the drawing is not required, nor are the drawings the main or sole reason why you should participate in AMBITION. Among other benefits, AMBITION offers its participants educational sessions, informative presentations and networking opportunities. **There is a limit of one (1) entry per person for general sessions on Thursday and Friday, September 3 and 4 of 2026 as well as the general drawings on Saturday, September 5 of 2026.** Depending on when you register will determine the number of entries you will have in the grand prize drawing on Saturday, September 5 of 2026.

- Register by Sunday, Aug 16, 2026 at 11:59pm and receive 2 tickets in the grand prize drawing.
- Register Onsite and receive 1 ticket in the grand prize drawing.

All entries become the sole and exclusive property of Sponsor. Entries will not be returned and receipt of entries will not be acknowledged.

3. ELIGIBILITY. Eligibility is limited to persons at least twenty-one (21) years of age, who are legal residents of the United States or its territories and possessions, and who are registered and in attendance at AMBITION. Each participant who registers and checks in for AMBITION by the morning of September 5, 2026 will be eligible for the Sweepstakes. The drawing is subject to all applicable federal, state and local laws and regulations and void where prohibited. Employees (and their immediate families and household members) of Ambit, its parents, affiliates, subsidiaries, and advertising and promotion agencies are not eligible to participate in the drawing. The first prizes for group A have an approximate retail values (“ARV”) ranging from \$500-\$15,000.

eight (8) numbers of potential grand prize winners. The eight (8) will then play a game to win a Grand Prize. One (1) player will win the Grand Prize. The remaining seven (7) of the original eight (8) drawn will receive a prize for playing the game. Only seven (7) total will win alternative prizes and only one (1) total will win the Grand Prize. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
