AMBIT CARES VIRTUAL RAFFLE OFFICAL RULES AND DISCLAIMERS

- 1. Purchaser of virtual raffle tickets must qualify under applicable law. This virtual raffle is intended for participation in the State of Texas in the United States only and shall be construed and evaluated according to the laws of the State of Texas and the United States. Winners must be at least 18 years old. VOID WHERE PROHIBITED BY LAW.
- **2.** Ambit Cares (the "Operator") is selling these virtual raffle tickets in accordance with applicable laws and the ticket holder is subject to the same, and, by purchasing a ticket, the purchaser consents that he/she is not prohibited from purchasing a ticket. Operator is a qualified 501(c)(3) nonprofit organization.
- **3.** Purchaser will complete the online ticket registration form for each ticket payment received following purchase of same.
- **4.** Tickets will be purchased online at AmbitCares.org for \$1 per ticket. Purchaser may purchase a ticket for an amount greater than \$1 by typing in their own desired amount. They will then be directed to submit payment and will receive a confirmation email that will serve as their "ticket." Names will be drawn four times throughout the AMBITION event, August 28-30, 2025, for prizes that increase in amount with each drawing. Winners can come to the Ambit Cares booth to collect their prize. All donations will go to Ambit Cares and will be matched by Vistra as part of our donation matching campaign.
- **5.** The virtual raffle will close at 4:00 p.m. CT on Saturday, August 30, 2025, or when 3,500 registration forms are in the possession of Ambit Cares or its representatives, whichever occurs first. Any registration forms and payment turned in after the closing of the virtual raffle that exceed 3,500 total registration forms will be collected as a donation to Ambit Cares but will not be eligible for the drawing.
- **6.** Accounting reports, detailing receipts and ticket numbers will be maintained by Ambit Cares.
- **7.** There will be four (4) drawings and the selected ticket holder for each drawing will win one of the following prizes: an Ipad, \$300 Target gift card, a \$200 Amazon gift card, or a set of Ambit Cares Yeti Tumblers (total prize value of \$1000).
- **8.** The drawings will occur on August 28, 29 and 30, 2025 during the AMBITION live show.
- 9. Purchaser needs to be present to win.
- **10.** Winners present at the event when their name is drawn may come to the Ambit Cares booth to collect their prize.
- 11. Winner will assume and be responsible for all licensing, registration and all other fees and local, state and federal taxes,

including, without limitation, all applicable sales, use, luxury, income, special taxes and insurance. In addition, winner must present identification to collect a prize (e.g. driver license, social security card, voter identification card, etc.) to verify his/her name and address.

- 13. The Operator or any other person, organization, or business associated with this virtual raffle shall not be liable for any claims for injury or other damages arising from this virtual raffle. Operator is not responsible for lost, late, incomplete, damaged, stolen, misdirected, or illegible entries; lost, interrupted, or unavailable network, server, or other connections, garbled transmissions or miscommunications, telephone transmission problems; computer or software malfunctions or damage to a user's computer equipment (software or hardware); technical failures; postal delays or errors; or other errors or malfunctions of any kind whether human, mechanical, electronic, or otherwise.
- **14.** The prizes will be purchased and held by the Operator prior to the virtual raffle. The type of prizes will be selected by Operator in its sole discretion.
- **15.** Operator reserves the right to cancel this virtual raffle, at any time, and return all proceeds from ticket sales to the rightful purchasers.
- **16.** Approximately 3,500 tickets are to be sold. Your odds of winning are at least 1:3500, but the exact odds will depend on the actual number of tickets sold.
- 17. All decisions relating to the conduct of the virtual raffle will be made by Ambit Cares, whose judgment on all matters will be final.
- **18.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of Operator in connection with the virtual raffle, shall be governed by, and construed in accordance with, the laws of the State of Texas, without regard for conflicts of law doctrine.
