Our Privacy Commitment to You

This Policy applies to our collection and use of personal information. It describes the company's practices regarding the collection, use, disclosure, and sale of personal information when you visit our websites, use our mobile applications and engage with us offline. When you use our sites and services, you consent to our data practices as explained in this Policy.

We may update this Policy from time to time to reflect changes in data practices, our business or the law. When we make changes to this Policy, we will post the updated Policy with the effective date on our websites. **By continuing to use our sites following the posting of our changes, you accept and agree to the updated Policy.**

This Policy does not apply to information we collect about employees, job applicants, and independent contractors (for which we have distinct privacy policies).

We are committed to protecting your personal information. For the purposes of this Policy, personal information means information that identifies, relates to, describes, is reasonably capable of being associated with, or could be reasonably be linked, directly or indirectly, with a particular individual.

What Information We Collect

We collect personal identifiers, financial information, commercial information, internet or other electronic activity information, and information related to our provision of energy services to you, such as energy usage or billing information, as well as inferences drawn from any of the personal information identified above.

We collect personal information for specific business purposes, including providing you with retail and industrial energy services, supporting our energy business, and communicating with our business contacts. We also use your personal information, including your interactions with our site and services for marketing purposes to inform you about additional goods or services that may interest you.

How We May Collect Information

We may use "cookie" technology on our websites. "Cookies" are small text files used by a website to recognize repeat users, facilitate the user's access to and use of the site, and to track behavior on the website pages you visit, among other uses. Our websites may automatically collect cookies and other information, including, but not limited to, your domain name. We may compile aggregate data for statistical purposes in order to improve the content of our websites or to better administer the web pages available on our websites.

Our cookie usage includes, but is not limited to, advertising Cookies. For example, we use Google Analytics to evaluate the use of our websites. Google Analytics uses cookies and other identifiers to

collect information, such as how often users visit a website, what pages they visit when they do so, and what other websites they visited prior to visiting a website. We also leverage SessionCam and Liveramp on certain sites, which helps us better understand how you use and interact with our websites. How We May Share Your Information

We will not sell, share or make your personal information available to unaffiliated companies for commercial purposes unrelated to the business of the company except as specified in this Policy.
