

E-Sign Disclosure and Consent Agreement



This E-Sign Disclosure and Consent Agreement applies to all communications for those products and services offered through the Ambit website that are not otherwise governed by the terms and conditions of an electronic disclosure and consent.

SCOPE OF COMMUNICATION

You agree that we may provide you with any electronic communication that we may choose to make available in electronic format, to the extent allowed by law, and that we may discontinue sending paper communication to you, unless and until you withdraw your consent as described below. Your consent to receive electronic communications and transactions includes, but is not limited to:

- All legal and regulatory disclosures and communications associated with your Independent Consultant account.
- Notices or disclosures about a change in the terms of your Independent Consultant account.
- Privacy policies and notices.

METHOD OF PROVIDING COMMUNICATIONS

All communications that we provide to you in electronic form will be provided either (1) via email, (2) Power Zone, (3) by access to a web site that we will designate in an email notice we send to you at the time the information is available.

You may request a paper version of an Electronic Communication. You acknowledge that Ambit reserves the right to charge you a reasonable fee for the production and mailing of paper versions of Electronic Communications. SYSTEM REQUIREMENTS

The following are the minimum hardware, software and operating system requirements necessary to access Ambit's web system and receive Electronic Communications:

- an internet browser that supports 128 bit encryption;
- sufficient electronic storage capacity on your computer's hard drive or other data storage unit;
- an email account with an internet service provider and e-mail software in order to participate in our electronic communication program;
- software which permits you to receive and access Portable Document Format ("PDF") files.

WITHDRAWING CONSENT

You have the right to withdraw your consent to receive/obtain communications via Ambit's web system at any time. If you wish to withdraw your consent, contact us at 877-302-6248.

UPDATING YOUR RECORDS

You agree to keep Ambit informed of any changes to your email address and other contact information related to your Independent Consultant account. You may modify your email address by submitting a written request to Ambit or a secure message through Ambit's web system. Ambit may notify you through email when an electronic communication pertaining to the Independent Consultant Agreement is available.

COMMUNICATIONS IN WRITING

All communications in either electronic or paper format from us to you will be considered "in writing." You should print or download for your records a copy of this disclosure and any other communication that is important to you.

CONSENT

By typing your name on the signature line, you are signing the Independent Consultant Application Agreement and its occupying Policies and Procedures (herein "Agreement") electronically. You agree your electronic signature is the legal equivalent of your manual signature on this Agreement and you consent to be legally bound by this Agreement's terms and conditions. You also agree that no certification authority or other third party verification is necessary to validate your E-Signature and that the lack of such certification or third party verification will not in any way affect the enforceability of your E-Signature or any resulting contract between you and Ambit. You also represent that you are authorized to enter into this Agreement for all persons who are authorized to access your account and that such persons will be bound by the terms of this Agreement.
